**Recruitment of General Manager (Information Technology),
Odisha State Cooperative Bank**

Applications are invited in the prescribed format from intending candidates fulfilling the eligibility criteria stated below for the post of General Manager (IT) of the Odisha State Cooperative Bank.

1) Eligibility Criteria as on 01.04.2018 :

- The candidate should preferably be below 40 years of age as on 01.04.2018. In deserving cases, upper age limit may be relaxed.
- The candidate should at least be a B.E. (Computer Science)/ B.Tech. (Computer Science)/ M. Tech. (Computer Science)/ M.Tech. in Allied Subjects to Computer Science/ MCA from any recognized University/ Institute. However, Degree in Computer Science shall be preferable.
- The candidate must have experience in development/ analysis/ design of software for a period of not less than 10 years and preferably should have experience in Data Centre Management for at least 5 years.

2) Scale of Pay and other allowances :

The post carries a Scale of Pay of Rs.68500-2150(2)-72800-2250(6)-86300 (9 years) with Grade Pay of Rs.8,000/- and all other allowances as admissible under the Staff Service Rules of the Bank. In deserving cases, the salary will be negotiable.

3) Job responsibilities :

The Odisha State Cooperative Bank has implemented an integrated Core Banking Solution (CBS) Project for its operations and for the District Central Cooperative Banks. It has also installed a Data Centre in its premises for the purpose and the Disaster Recovery Centre is hosted at the BSNL Data Centre, Faridabad. Besides, OSCB has been appointed as the Nodal Agency by the Government of Odisha for implementation of the PACS Computerisation Project, which is at its fag end of grounding. The General Manager is expected to maintain the CBS project including its hardware and software, which should be robust to take care of the compliance level as stipulated by the Reserve Bank of India and NABARD from time to time. He/ She shall directly report to the Managing Director of the Bank in respect of computerized operations of the Bank and its affiliated CCBs and the PACS. He/ She will also be responsible for development of specific modules that would be required to comply with the directives of Reserve Bank of India/ NABARD to be issued from

time to time concerning the banking operations. He/ She should be innovative for development and design of software/ specific products in respect of computerized operations. He/ She should be a fast learner and proactive in the work environment. He/ She will be responsible for follow-up, monitoring, maintenance and updation of the computerized operations for which, he/ she may have to make extensive tours to the different parts of the entire State.

4) Process of Selection:

The selection may be through a Written Test followed by Interview or by Interview alone by a Committee to be constituted for the purpose.

5) Verification of certificates at the time of Viva Voce Test :


- Matriculation/ High School Examination Certificate or an equivalent certificate to establish the date of birth.
- All certificates pertaining to the career of the candidates as mentioned in the Application Format.
- Experience Certificate as mentioned in the Application Format.
- 3 copies of Colour Pass Port Size photographs.

6) How to apply:

The candidates have to submit the filled in application in the prescribed format alongwith self-attested photocopies of all the required certificates / testimonials. They have to submit No Objection Certificate for applying to the post from their respective employers.

7) Last date of submission of application :

The application should reach the Managing Director, Odisha State Cooperative Bank, Pandit Jawaharlal Nehru Marg, Bhubaneswar – 751 001 **on or before 30.04.2018**. Any application received after the stipulated date will not be considered. Applications of ineligible candidates shall be summarily rejected and no correspondences in the matter of rejection shall be entertained on any circumstances. Intending candidates are, therefore, advised to make a self assessment of their eligibility for the post before submitting the application.
