- 2. Copy of the call letter, when you come for Viva-voce test and report at the Venue.
- 3. Proof of Date of Birth (Birth Certificate or Matriculation / High School Examination Certificate issued by Board of Secondary Education, Odisha or equivalent certificate issued by any recognized Board/ Council / Indian University).
- 4. Matriculation / High School Examination and all other examinations mark-sheets and certificates or an equivalent certificate in support of qualifications mentioned in the registered application form as on the date of submission application will only be accepted.
- 5. Residential Certificate issued by Competent Authority (issued not before the date of advertisement).
